**Program Summary:** Wendel Energy conducted a comprehensive energy audit of 8 of Beacon's buildings in 2011. This represents 92K sq feet, most of Beacon's buildings, including our Municipal Center, all three fire houses, the memorial VFW building, and the water treatment plant and water well sites. The only major buildings not included in the audit are the highway garage and the transfer station (as well as some buildings like the salt shed and yard fixtures.)

**Program Summary:** The City hired a contractor via Central Hudson to upgrade City Hall lighting fixtures in 2015. The details are attached, including a page detailing the building square footage. Our highway garage was built after the list was compiled, but its square footage is estimated to be 20,000 sq ft. At 112,000 total sq. ft, we estimate the 20,000 sq foot municipal center makes up about 10-15% of the total square footage of city government buildings.

**Program Summary:** Between 2012 and 2019 the City of Beacon converted traffic lights and signals to LEDs to save energy. The city also installed a solar farm on a decommissioned landfill via a Power Purchase Agreement. In 2012 the City's facilities (buildings, solid waste, waste/water treatment, street lights) emissions were: 1448 MTCO<sub>2</sub>E In 2019 the City's facilities emissions were: 938 MTCO<sub>2</sub>E This is a 35% reduction in Scope 1 and Scope emissions from city facilities. <https://www.cityofbeacon.org/index.php/departments/sustainability/> - All inventories are available on the City's website.
